The committee was also informed in detail about the salient features and targets proposed in thrust areas in the APO for 2021-22. The sector-wise abstract of proposed APO of Rs. 136.91 crore was placed before the EC for perusal and approval before placing it before the Steering Committee.

Decision Taken: The Executive Committee after detailed discussions suggested a few changes in APO outlay of NPV Sector. As per recommendations of EC the proposed amount under the component 'Pest and Disease Control in Forests', 'Management of Biological Diversity and Resources' and 'Monitoring & Evaluation' works has been enhanced and revised outlay under NPV Sector has also been raised from 76.10 crore to 77.29 erore.

Accordingly, the total outlay of APO proposed got revised from Rs. 136.91 crore to the tune of Rs. 138.10 crore for the financial year 2021-22. The Executive Committee approved the total Outlay of APO of Rs. 138.10 crore as per Annexure B.

AGENDA ITEM - 4.4

Award of third party monitoring work of CAMPA Funded Plantations

The Executive Committee was intimated that third party monitoring of CAMPA funded plantation works carried out during the years 2016-17 to 2018-19 was awarded to Irinalayan Forest Research Institute (HFRI), Panthaghati for INR 51 lacs. It is further informed that due to COVID, 2019, monitoring period has been extended up to 31.03.2021.

Decision Taken: The Executive Committee perused the agenda item and suggested to get the work of third party monitoring for back log years expedited. It was opined by the committee that a common Expression of Interest shall be invited for both CAMPA funded plantations as well as State Budget funded Plantations in order to minimize the financial bid cost per hectare because of large extent are areas to be monitored, involved. However, the cost of monitoring work shall be borne by the respective plantations funding agencies. In view of this provision made under Monitoring & Evaluation activity was also got enhanced from Rs. 31 lacs to 50 lacs.
