The decisions taken on the agenda items of the meeting are as under:-

AGENDA ITEM - 7.1

Action Taken Report on the decisions taken in 6th meeting of Executive Committee.

Action Taken Report (ATR) on the decisions taken in the 6th meeting of the Executive Committee of H.P State Authority (CAMPA) was placed before the Executive Committee of State Authority for favor of perusal and approval.

Decision Taken: The Executive Committee perused the Action Taken Report and approved. Agenda stands dropped.

AGENDA ITEM -- 7.2

APO $_{t_{\rm min}}^{\rm corm}$ -Progress Report for the 2021-22

The EC was apprised that during 2021-22, National Authority, CAMPA has approved the APO amounting to Rs. 138.10 crore and against which expenditure of Rs. 94.77 was incurred by HP State Authority. The detail of head/sector wise expenditure as per revised outlay was placed before the EC for favour of perusal and approval.

Decision taken: The Executive Committee perused the head/sector-wise detail of expenditure incurred during F.Y. 2021-22 and suggested to prepare APOs keeping in view the expenditure incurred during previous years and APO should be prepared and approved timely so that the funds could be allotted accordingly and the expenditure can be made. The EC perused and approved the same for placing it before Steering Committee of State Authority for approval.

AGENDA ITEM - 7.3

APO-cum-Progress Report for the 2022-23

The EC was apprised that during 2022-23, National Authority has approved the APO amounting to Rs. 190.23 crore against which GoHP released an amount of Rs. 140.01 crore. Out of the total received amount the expenditure of Rs. 25.00 crore was incurred upto 18.11.2022 the remaining works are in progress and the final position will be apprised in the next meeting after closing of the financial year.

Decisi Taken: The Executive Committee perused the progress of expenditure upto 18.11.2022 and suggested to gear up the pace of expenditure. It is suggested by the EC that the APO from field offices will be prepare as per the actual demand for concerned financial year.

AGENDA ITEM - 7.4

Annual Reports for the F.Y. 2015-16 and 2016-17

Executive Committee was apprised that the annual accounts for the year 2015-16 and 2016-17 have been converted on double entry accounting system and balance sheets have been audited by AGHP. Resultantly, the annual reports for both the F.Y 2015-16 and 2016-17 have been completed. The balance Sheet for the F.Y. 2017-18 have been prepared and submitted to AGHP and conversion of accounts for the balance year 2018-19 to 2020-21 are under active progress. Annual reports of State CAMPA for the years 2015-16 and 2016-17 duly audited and compiled are placed for favor of kind perusal and approval of the Executive Committee

The balance Sheet for the F.Y. 2017-18 have been prepared and submitted to AGHP and conversion of accounts for the balance year 2018-19 to 2020-21 are under active progress and it

will require some more time for completion, therefore EC is requested to extend the period of one Account supervisor and Two Office Assistants till 31.03.2023.

Decision Taken: The Executive Committee, after detailed discussions and deliberations, approved the same.

AGENDA ITEM 7.6

Revision of Wages of MPW

The EC is apprised that at present two number of Multi Purpose workers are engaged in the office of HP State Authority CAMPA through outsourcing agency NRTC Parwanoo on outsource basis. On the basis of the GoHP notification regarding revision of wages it is proposed that minimum wages of Rs. 10500/- may be paid to both the MPWs.
