### PROCEEDINGS OF 11th MEETING OF STEERING COMMITTEE OF HP STATE CAMPA HELD ON 08.06.2015.

The 11<sup>th</sup> meeting of Steering Committee of Himachal Pradesh Compensatory Afforestation Fund Management and Planning authority [HP State CAMPA] was held under the Chairpersonship of Shri P. Mitra, Chief Secretary to the Government of Himachal Pradesh on 08.06.2015 in the CS Committee Room, HP Secretariat, Shimla. The list of participants is attached as Annexure-1.

At the outset, the Member Secretary of the Committee welcomed the Chairperson and other members of the Steering Committee to the meeting. Thereafter, the Agenda Items were taken up for discussion and decision. In the meeting, all the agenda items were discussed and deliberated upon in detail and following decisions were taken:-

# AGENDA ITEM - 11.1: Confirmation of the Minutes of 10th Meeting

The minutes of the 10<sup>th</sup> meeting of HP State CAMPA Steering Committee held on 31<sup>st</sup> July 2014 were circulated to all the members of the Committee. No comments on the minutes of the meeting were received from any of the members. The proceedings of the meeting placed at Annexure-1 of the agenda were submitted for perusal and confirmation.

Decision Taken:

The Steering Committee perused the Action Taken Report and approved the acrions proposed thereon except further directions on the following agenda items:

1. 8.10 Utilization of Funds Parked with DIAs Outside the HPFD: On the issue of non-utilisation of funds by the Urban Development Department, it was decided that the ACS (Forests), GoHP will take up the matter with the concerned department to expedite the utilisation of balance unspent amount.

## AGENDA ITEM NO. 11.3: Revised APO for 2014-15

During the Year 2014-15, the total APO of Rs. 11869.50 Lakh approved by the Steering Committee was submitted to Adhoc CAMPA for funding. Later, the Adhoc CAMPA intimated that the release of only Rs. 96 crore becomes due @ 10% of total deposit of Rs. 960 60 crore in the account of HP State excluding the amount of Rs. 226.35 crore deposited by Koldom HEP in the diversion case of forest land in Majathal WLS under Wadlife Protection Act which is to be managed separately and utilised on the Conservation And Protection of Protected Areas in HP.


#### AGENDA ITEM NO. 11.4: Progress Report of 2014-15


The Steering Committee perused the funds availability for 2015-16 and took note of the balance unspent amount of Rs. 16.56 crore.

The detailed APO 2015-16 of Rs. 95.60 crore, as placed at Annexure-4 of the Agenda, was submitted to the Steering Committee for approval.

Decision Taken:

After detailed discussions and deliberations, the Steering Committee approved the APO of Rs. 95.60 crore for the year 2015-16 for its submission to Adhoc CAMPA Gol for funding.

The Committee felt the need of wiping out the long pending backlog of Compensatory Afforestation (CA) at the earliest and decided that efforts to take up additional targets of CA during the current financial year itself may be made. To take up and accommodate additional targets of CA, if any, the provision of funds be made by reducing the outlay of CAT Plan APO 2015-16 as per requirement.

The Committee also observed that with the present outlay of Rs. 34.12 crore of NPV, there is limited scope of accommodating and achieving more targets under this sector. It was, therefore, decided that if needed, the funds may be spared from the component of Infrastructure Development and Non-biological works proposed in the CAT Plan APO and be diverted to the NPV APO to accommodate more activities and targets. The Chairperson of Executive Committee of HP State CAMPA is authorised to revise the sectorwise APO upto this extent. The APO, if revised, may be placed before the Steering Committee in its next meeting for formal approval.

The Committee decided that the approval of targets of plantations may be conveyed to the field offices at the earliest so as to take up the plantation works proposed and approved in the APO 2015-16 for implementation during the ensuing monsoon season.

The Committee also decided that in case the release of funds from Adhoc CAMPA is delayed, the funds to the field offices may be provided out of the interest income available with HP State CAMPA till regular release is received from Adhoc CAMPA.

#### AGENDA ITEM – 11.7: APO 2015-16 for Protected Area Corpus

The amount of Rs. 226.35 Crore has been deposited by Kol Dam HEP against diversion of forest land in Majathal WLS under Wildlife Protection Act which is to be utilised on the Conservation & Protection of Protected Areas in HP and is to be managed as a separate corpus. The Adhoc CAMPA has directed to prepare and submit a comprehensive plan of this amount for the Conservation and Protection of Protected Areas in HP. The Wild Life Wing of HPLD has formulated a Plan of Rs. 69.018 Crore against the total amount of Rs. 226.35 Crore claiming Rs. 157 Crore as cost of land for which the matter is under correspondence with MoEF.

This Plan of Rs. 69.018 Crore was placed before the Steering Committee, as Annexure 5 of the agenda, for approval.

Against this plan, an APO of Rs. 8.49 Crore for Conservation & Protection of Protected Areas formulated for 2015-16 was placed before the Steering Committee, as Annexure 6 of the agenda, for approval. The Steering Committee was requested to approve the Plan of Rs. 69.018 Crore and also the APO of Rs. 8.49 crore for 2015-16 prepared against the Protected Area Corpus for their submission to Adhoc CAMPA for funding.

The Steering Committee Approved the Plan of Rs. 69.018 crore for Conservation and Protection of Protected Areas in HP formulated against the Protected Area Corpus of Rs. 226.35 crore deposited by Koldam HEP for its submission to Adhoc CAMPA.

The Committee also approved the APO of Rs. 8.49 crore for 2015-16 for the Conservation and Protection of Protected Areas in HP formulated against the Protected Area Corpus of Rs. 226.35 crore deposited by Koldam HEP for its submission to Adhoc CAMPA for funding.

#### AGFNDA ITEM - 11.8: Funding of ETF Companies

Two companies of Eco Task Force (ETF-A & ETF-B) have been established in the State. The initial tenure of ETF-A company was five years from 2007 to 2012 which was extended for two years upto 2014 and the tenure of ETF-B Company was 5 years from 2010 to 2015. The tenure of both the companies has been extended for further three years i.e. upto 2017 & 2018 respectively.

Upto the year 2012-13, the expenditure of ETF-A company was met out of funds provision of Rim Plantation Scheme of Koldam HEP and part out of the provision of non-executable works of CAT Plan of Koldam HEP and that of ETF-B on the CAT Plan of Larji HEP. After having the funds provision of these schemes exhausted, the Steering Committee permitted the expenditure of both these companies to be loaded on the CAT Plans of Shongtong Karchham and Miyar HEPs where the provision for ETF was made. Thus, both these companies continued to be loaded on the CAT Plan of Shongtong Karchham HEP from 2013-14 onwards.

The Steering Committee, in its 10<sup>th</sup> meeting, decided that the expenditure on both the LH companies shall continue to be loaded on the CAT Plans till some alternative source of funding could be found.

The Committee was apprised that against the total provision of Rs. 21.40 crore in the CAT Plan of Shongtong Karchham HEP, an expenditure of Rs. 16 crore has been incurred and an amount of about Rs. 5.4 crore only is available for 2015-16. The User Agency of Miyar HEP has not yet deposited the funds. The annual expenditure of both the ETF companies comes at about Rs Prore. It was also intimated that adequate funds were not available to meet the requirement of 2015-16 and that the alternative source of funding had also not come up. The Steering Committee was requested to take a decision on the issue of ETF funding

Decision Taken: On the issue of funding of ETF companies, the Steering Committee decided that these companies will continue to be loaded on the CAT Plans. In view of the limited availability of funds under the CAT Plan of Shongtong Karchham HEP, it was decided that the existing CAT Plans may be revised to make provision for ETF, wherever feasible by reducing the provision of non-biological works. The Chairperson of Executive Committee of HP State CAMPA was authorised to revise the CAT Plans up to this extent.



The emoluments of officials to be engaged were to be met out of the CAT Plans within the existing provisions in Chamba Circle, Operational Support of NPV in Nurpur Division and from Interest Income at CAMPA office. The proposal was placed before the Steering Committee for consideration and approval.

Decision Taken:

The proposal of engagement of Multi-Purpose Worker (MPW) on contractual basis through service provider was discussed in detail. It was decided that the availability of surplus Forest Workers in the Forest Department may first he analysed to see if they can be deployed for this purpose. Only thereafter the issue of hiring MPWs can be considered.

#### AGENDA ITEM - 11.10: Procurement of Vehicle

Since its coming into being, the sphere of CAMPA working has increased manifold. The mosility requirement of staff and officers has also increased considerably. To meet up this need, it was proposed that a vehicle may be procured and kept as a pooled vehicle in CAMPA office for sundry requirements. The services of one driver are required to be hired through service provide for plying the vehicle.

The expenditure of about Rs. 13.00 Lakh on the procurement of new vehicle was to be met from the interest income of CAMPA. The proposal was placed before the Steering Committee for consideration and approval for purchase of vehicle as also hiring the services of one driver through service provider to ply the vehicle.

The Steering Committee, under Agenda Item No. 10.7 of its 10<sup>th</sup> meeting held on 31.07.2014, decided that fixed emoluments of Rs. 13500/- per month would be paid to the Computer Operators engaged on contract basis in Rampur circle in line with the emoluments being paid by the HP State Electronics Development Corporation and in accordance with HP govt of tification No. Fin (C) B(7)5/2009 dated 03.12.2009.

It was submitted that the CAMPA guidelines provide for contractual engagement of personnel for the management of the State CAMPA BY utilising a part of the income from interest received by it on funds invested by State CAMPA.

The Committee was apprised that the HP State CAMPA has engaged contractual staff from NRTC Parwanoo, a Society under State Council of Science Technology and Environment, for the management of CAMPA office. Initially the NRTC Parwanoo deployed the Computer Operators @ Rs. 7000/- per month. Now, it was intimated that they had also fixed the emoluments of Rs. 13500/- per month for Computer Operators as per GoHP Notification dated 03.12.2009 and Rs. 15000/- per month in respect of Project Associate and had sent the proposal for revision of emoluments of deployed contractual employees for acceptance.

It was proposed that fixed emoluments of Rs. 13500/- per month be paid to contractual Computer Operators all across CAMPA in uniformity with the emoluments of Computer Operators of Rampur circle already approved by the Steering Committee and also Rs. 15000/- per month to contractual Project Associate as proposed by the NRTC. Writing off loss of Rs. 9.08 Lakh: Chief Wildlife Warden-cum- Principal CCF (WI) intimated the Steering Committee that the site developed for the construction of WL Interpretation Centre at Dadwa (Bharmour) was totally damaged due to heavy rain and unprecedented massive land slide which resulted in net loss of Rs. 9.08 Lakh and requested for conveying approval to write off the loss.

Decision Taken: The Steering Committee observed that it was an administrative issue and required to be processed in accordance with the provisions of Financial Rules. It was decided to take further action accordingly.

O Gap Filling of Forest Areas: The Principal CCF (HoFF) intimated the Steering Committee that some old plantation areas need to be rehabilitated by planting tall plants in gaps to improve their density to optimum level and some other subsidiary works. For this a new plantation model should be introduced under NPV sector.

Decision Taken: The Steering Committee approved the activity of rehabilitation and Gap Filling of Forest Areas for introducing and taking up under NPV.
