As per provisions contained in R & P Rules of Clerk and JOA(IT) notified vide Government of HP Notification No. Per(AP)-C-A(3)-1/2010 dated 14.09.2011 and No. Per(AP)-C-A(3)-1/2007-III dated 26.09.2022, there is 10% quota for promotion of Class-IV employees to the post of Clerk/JOA(IT). The above promotion are subject to the following terms and conditions:-

- (i) They shall be on probation for a period of two years.
- (ii) Promotion shall be effective from the date of joining. In case a candidate fails to join duty by 14.08.2024, he/she will be reverted to his/her respective post of Class-IV without any notice and next candidate in seniority of eligible candidates will be promoted.
- (iii) The above officials now promoted to the rank of Clerk/JOA(IT) are liable to serve anywhere in Himachal Pradesh and bound to serve in subcadre/tribal areas as per provisions in R & P Rules.
- (iv) As per report of concerned offices there is no court/departmental/vigilance cases pending against the above named officials. However, these offices are advised to check the same again and if there is any discrepancy, the same should be pointed out immediately.
- (v) The Class-IV officials so promoted as Clerk/JOA(IT) shall mandatorily have to qualify the prescribed typing test on Computer with a minimum speed of 30 words per minute of English typing or 25 words per minute of Hindi typing within the probation period. The incumbents will get three chances during the probation period as per provision of R & P Rules. If the candidate fails to qualify the typing test within the prescribed period, his/her probation will be extended. During this period the incumbents will get one more chance. If the candidate still fails to qualify the typing test in the extended period, he/she will be reverted from the post of Clerk/JOA(IT) to their respective Class-IV post.
- (vi) Other conditions of service will be governed by the relevant rules and orders from time to time.
