The Power to sanction Tender upto 10% above the reserve price, shall be exercised by the Higher Authority. 3. Full powers to sanction the Tender above 10% of the reserve price shall be exercised by the Principal Chief conservator of Forests

These powers shall come into force with immediate effect.
