(b) The service of the Contract Appointee will be purely on temporary basis. The appointment is liable to be terminated in case the performance/conduct of the contract appointee is not found satisfactory.
(c) Contractual appointment shall not confer any right to incumbent for the regularisation in service at any stage.
