Whereas, the Governor of Himachal Pradesh, in exercise of the powers conferred by section 4 read with section 7 of the Himachal Pradesh Land Preservation Act, 1978, had issued Order No. FFE-B-A(3)-4/99, dated 10.09.2002 for temporarily regulating restricting and prohibiting throughout the areas in Himachal Pradesh (Except the areas falling within the limits of Municipal Corporation, Municipal Councils, Nagar Panchayats and Cantonment Boards) as specified in Schedule appended to the said Order, the acts specified therein for a period of 30 years from the publication of the said Order in Rajpatra, Himachal Pradesh and the said order was published in the Rajpatra, Himachal Pradesh dated 4th October, 2002;

And whereas, vide Order No. FFE-B-A(3)-1/2017, dated 8th February, 2021, some provisions of para-1 of the above Orders were amended;

And whereas, the State Government after due inquiry is satisfied that it is necessary and expedient to modify the said order dated 8th February 2021 in the interest of maintenance of ecology, forest and wild life conservation and for preventing the exploitation of farmers;

Now, therefore, in exercise of powers conferred by section 4 read with section 7 of the Act ibid the Governor of Himachal Pradesh is pleased to make the following amendments in the said order namely:
