Accordingly no officer/official shown in the Annexure to the instructions ibid, can henceforth purchase land/building/immovable property with the respective jurisdiction of posting in his/her own name or in name of any of the family members, Further, the officers/officials, who are transferred out, will also not be allowed to purchase land/building/immovable property within the recent jurisdiction and the purchase deed will not be allowed to be registered in his/her name or in the name of his family member (s) within a period of two years from the date of relinquishing the charge of his /her post.

am directed to refer to the instructions contained in this Department letter of even number dated 29.7.1989 and subsequent modified instructions issued vide this Department istter of even number dated 3.6.1992 on the subject noted above wherein it has been laid down that if a government servant, except those indicated in the 'Annexure' to the instructions dated 3.6.196 intends to purchase land in his name or in the name of any of his family members within the jurisdiction of his posting can do so only with the order permission of the competent authority as regulated under the Conduct Rules.
