NOTIFICATION

WHEREAS, the Government of Himachal Pradesh has fixed the price of private forest produce under Section-7 of the Himachal Pradesh Forest Produce (Regulation of Trade) Act, 1982 from time to time. The rates were revised from time to time in subsequent years, though, the terms & conditions remained the same as laid down in the GoHP Notification No. FFE-B-A(4)-3/2005-Vol-I dated 31<sup>st</sup> March, 2011.

NOW THEREFORE, in exercise of the powers conferred by first proviso of Section 7 of the Himachal Pradesh Forest Produce (Regulation of Trade) Act, 1982, the Governor, Himachal Pradesh is pleased to fix the price of private forest produce for the Financial Year 2021-22 by enhancing 10% in the existing rates fixed for the Financial Year 2020-21 notified vide Notification of even number dated 20<sup>th</sup> June, 2020. Further, handling charges on sale realization in respect of private timber shall remain 9% as per aforesaid GoHP Notification of even number dated 20<sup>th</sup> June, 2020. The list of revised rates applicable w.e.f. 01-04-2021 is enclosed as Annexure-I.

All other "terms and conditions" as prescribed in above referred GoHP Notification dated 31<sup>st</sup> March, 2011 shall remain the same.

RATES OF PRIVATE FOREST PRODUCE FOR THE YEAR  
2021-22.**

In order to fix the rates of Private Forest Produce for the year 2021-22, a meeting was held under the Chairmanship of Additional Chief Secretary (Forests) on 23.03.2021. The following were present in the meeting:-


The Pr. Chief Conservator of Forests briefed about the provision of Section-6 of the H.P. Forest Produce (Regulation of Trade) Act, 1982. She also informed that under Section-6 of the H.P. Forest Produce (Regulation of Trade) Act, 1982, the Government is required to constitute Advisory Committee for each Division in which forest produce is grown or found for providing fair and reasonable price. In case the committees, fail to tender advice by 15<sup>th</sup> February preceding the financial year to which it relates, the State Government may under Section-7 of the Act proceed to fix the price without consultation of the Committees.


Due to non tendering of advice by the Advisory Committees, it was decided to fix the price of Private Forest Produce




for the Year, 2021-22. After detailed deliberations and taking into account the cost of timber, market trend, availability of the produce and various other factors prescribed under the rules, it was decided that the existing price of Private Forest Produce may be enhanced by 10% in respect of all species for fixation of price for the financial year 2021-22. Accordingly, a notification shall be issued.


