NOTIFICATION

WHEREAS, the Government of Himachal Pradesh has fixed the price of private forest produce under section-7 of the Himachal Pradesh Forest Produce (Regulation of Trade) Act, 1982 from time to time. The rates were revised from time to time in subsequent years, though, the terms & conditions remained the same as laid down in the GoHP Notification No. FFE-B-A(4)-3/2005-Vol-I dated 31<sup>st</sup> March, 2011.

NOW THEREFORE, in exercise of the powers conferred by first proviso of Section 7 of the Himachal Pradesh Forest Produce (Regulation of Trade) Act, 1982, the Governor, Himachal Pradesh is pleased to fix the price for the Financial Year 2022-23 for private forest produce in all Forest Divisions except Chamba Forest Division in respect of Deodar and Kail species by enhancing 15% in the existing rates fixed for the Financial Year 2021-22 notified vide Notification of even number dated 26-03-2021 and in respect of Chamba Forest Division, the price of Deodar and Kail Species for the Financial Year 2022-23 are enhanced by 23% and 20% respectively on the existing rates fixed for the Financial Year 2021-22.

Further, the Governor of Himachal Pradesh is also pleased to enhance the handling charges on sale realization in respect of private timber lots from 9% to 12% for the Financial Year 2022-23. The list of revised rates is enclosed as Annexure-I.

All other "terms and conditions" as prescribed in this Department's notification referred to above shall remain unchanged.




